Mayor Venable advised that a determination would be made to either settle the claim brought by David Black against the Village of Cloudcroft or not to accept the negotiated settlement. Mayor Venable called for a motion to settle for \$110,000 of which the Village of Cloudcroft would be obligated to pay \$35,000 with the remaining \$75,000 portion and mediation fees to be paid for by the New Mexico Self Insurers Fund and to authorize Mayor Venable to sign any and all paperwork necessary to finalize the claim. The settlement will be in accordance with the terms of the email by Christina Brennan on July 2, 2020 at 2:23 p.m. Trustee Denney made such motion, Trustee Mitchell seconded the motion and with no further discussion a roll call vote was taken.
