## **9-10-2: EXEMPT SIGNS NOT REQUIRING PERMIT:**

### **C. Temporary Unlit Banners:**

1. Banner like signs, including, but not limited to, pennants, pennant flap, streamers and fliers advertising a business or other for profit entity, if approved in writing by the village administrator, may be displayed for not more than fourteen (14) days in a twelve (12) month period.

2. Application shall be made on forms provided by the village and submitted to the village administrator who shall refer such application to the planning and zoning commission for comment. Such application shall include a drawing of the sign reflecting color, size, and appearance, as well as the number and proposed location.

3. Such banner like signs shall conform as provided in section [9-10-5](#) of this chapter and must utilize a western/railroad motif as provided in section [8-2-6](#) of this code.

4. The village administrator after consideration of the comments by the planning and zoning commission may issue written approval with such conditions as determined to comply with the intent of this exemption with a copy to be kept by the village clerk for at least twenty four (24) months.
