Baxter Pattillo, from Alamotero Survey, submitted on behalf of R&R, LLC, an Application for Subdivision for a piece of property located within the territorial jurisdiction east of the Village of Cloudcroft. The legal description of the property is: ... "within U.S. Government Lots 13, 14, 19, 20, 21 & 22, Section 2 and U.S. Government Lots 16 & 17, Section 3, T16S, R12E, NMPM. The application was for a request to divide the said lot into two lots. The Commission reviewed the application and a Boundary Survey and Claim of Exemption No. 11 (5 Year Hold). Chair Blessum explained the provisions of Village Code 10-3-4, the "Alternate Procedure" for a request of subdivision consisting of no more than two parcels of land.
