Mayor Denney advised that he review the progress with the Public Works Supervisor and that he would get back with her. She questioned if this would be done by the next budget cycle and shared, she expressed that she would be at the next budget cycle meetings to ensure that we are moving forward and not spending monies that are not appropriately budgeted.
